AGEWELL - HELPLINE FOR OLDER PERSONS

Agewell Foundation aims to disabuse the popular mindset that regards old age with a sense of pity for their helplessness. Replacing it with an attitude of confidence, fostering respect for them and encouraging fortitude in them. And bringing a little certainty, even fun into their lives.

With this purpose in mind, Agewell-Helpline was set up for Older Persons. A network of thousands of volunteers is already at work in given areas. They are constantly alert to attend, to matters of medical or emotional nature, affairs to do with security as well as legal and financial advice. They are spread across 640 districts of India so that no cry for help goes unanswered.

Agewell Helpline for Older Persons endeavours to bring about a change in the perceptions about old age. It has been set up with the sole objective of providing assistance to older persons and helping them find solutions for their problems.




A REALITY CHECK - A national study (July 2014)

Agewell Foundation carried out a national level study to study the status of human rights of Older people in India, to assess the perceptions about human rights of older people in India, to identify responsible factors for dismal status of elderly human rights protection and to suggest or recommend some specific points to policy makers, planners and decision makers so that human rights of older people could be strengthened in future.

For the survey a representative sample of 50000 older people (27000 from rural areas and 23000 from urban areas) were interviewed spread across 300 districts of 25 states & Union Territories of India. Agewell volunteers' network spread across the country worked as interviewers for the survey. The interviews were conducted during the month of June 2014.

Data collected during the survey from the state of Rajasthan and Delhi was also analysed separately.





Conclusion of the Study

Level of awareness about human rights of older people in Indian society, particularly among older persons is very low. Being a developing country, despite fast increasing elderly population, there is no special focus on rights of elderly. Therefore protection of human rights of older people is still not a major issue for most Indians. Largely, over the years, India has developed into a complex society, with a wide mix of traditional values and modern lifestyle. Older people have acute sense of rights and wrongs, but they generally don't ask for specific provisions and applications for themselves.

Housing in old age

Most old people live in their own houses, with their families, but their living conditions are not comfortable and their harassment/mistreatment has become a common phenomenon. Housing conditions of most elderly are not healthy and comfortable. In urban areas there is an emerging trend of institutional care of older people living alone. There is a striking increase in destitute,

abandoned and dejected elderly, mostly in big cities, forced to live in pathetic conditions without any support system.

Food in old age

Proper and nutritious food is one of the major concerns in old age for many older people of India. Safe drinking water is another core concern in old age.

Financial status of older people

There is a contradiction so far as financial status of older people is concerned. Many older people have higher net worth value but they are hardly financially independent. They have to depend on their family members for their financial matters due to factors like financial illiteracy, declining health status, dependence on family members, etc.

Gainful engagement in old age

Despite willingness and ability to work in old age, there are hardly any gainful engagement opportunities for older people to get decent job and keep them active. In urban areas elderly people are suffering a lot due to nonavailability of gainful engagement in old age.

Social security system

Status of old age social security system including old age healthcare facilities is dismal as many older persons still have no access to primary healthcare in old age.

Safety and security in old age

Safety and security in old age matters most for older

persons as most of them find themselves marginalized and isolated. In urban areas since social interaction of older people is limited, they are more prone to become soft target of anti-social elements.

Disability in old age

Disability is a common phenomenon in old age, particularly in prime old age. Accidents and chronic illness are major causes of disability in old age. Disabled elderly need special attention and care.

Elder abuse

With popularity of nuclear family older people have become victim of elder abuse including, misbehave /Mistreatment, restricted social life, abuse/mental torture, denial of basic needs, physical harassment /assault, etc. Since most of the elderly spend their life within four-walls, they are primarily abused/harassed by their own family members with various excuses.

Age discrimination

Though age discrimination is prevalent throughout the Indian society, still it is not considered as big challenge by concerned stakeholders in India. In fast changing demographics and socioeconomic scenario, older people have now started raising their voice against age discrimination.




GENDER DISCRIMINATION AMONG OLDER WOMEN IN INDIA - A national study (February 2015)

Gender Discrimination in Old Age

Gender inequality is prevalent in India for centuries, which is deep-rooted in almost all Indian communities. Health, education, economic and political inequalities between men and women in India is common. Gender discrimination deprives women from availing benefits of development even in old age and marginalizes them from the mainstream.

Research & Advocacy Centre at Agewell Foundation has carried out a nationwide survey to study the issues related to gender discrimination in old age in India. For the survey a **representative sample of 50000 older persons** (27500 from rural areas and 22500 from urban areas) were interviewed spread across **330 districts of 26 states & Union Territories** of India. Agewell volunteers' network spread across the country worked as interviewers for the survey. The interviews were conducted during the month of December 2014 and January 2015.



Data collected during the survey from Delhi, Rajasthan and Uttar Pradesh was also analysed separately.

Conclusion of the Study

In changed socio-economic and demographic set up of India, elderly women face increased incidences of age discrimination, ageism, elder abuse and mistreatment of older community, which are strictly against any civilized society.

Awareness about gender equality in the society, particularly among older persons and protection of basic and human rights of elderly women is very urgent, particularly in view of their longevity.

To decrease the incidences of age-discrimination within families, society and at national level

various gender equality supportive measures need to be undertaken at various levels.

In India there is an urgent need for inclusive social security program for older women at grass root level while utilizing tools like education. value based generation, awareness research & advocacy in order to protect basic and human rights of older persons with special attention on elderly women.



In view of fast-paced modern lifestyle, ever-widening intergenerational gap, longevity of elderly women and comparatively miserable living conditions of elderly women, there is a pressing need to;

- Inculcate a sense of responsibility towards needs & rights of older women through curriculum of schools and colleges and promote traditional joint family system.
- Policy formulation of social security schemes dedicated to elderly women with special focus on widows, dejected, dependent elderly women and its implementation with a practical approach.
- Encourage social interaction of elderly women through various governmental, nongovernmental, individual mediums like Social Patrol, Health check-up initiatives, etc.

Under the campaign over 2.75 lac pieces of woollens, etc collected and distributed amongst over 1.75 lacs destitute and older people through distributions camps set up by volunteers across Delhi-NCR.

Agewell Foundation has organised **FREE CHECK UP CAMPS for screening hearing capabilities of old people (60+)**. Over 1400 old people facing hearing problems were benefitted by free check up done by trained and qualified audiologists. They were counselled accordingly.

HEALTHCARE EQUIPMENT DISTRIBUTION AMONG DESTITUTE ELDERLY (Slums of Delhi & NCR)

Agewell Foundation has been conducting healthcare equipment distribution campaigns to provide medical accessories to destitute elderly in Slums of Delhi & NCR for 3 years. During the year under review, Agewell volunteers identified over 5000 destitute & elderly as prospective

beneficiary under the project. Agewell volunteers organized camps in various localities as per the convenience of the beneficiaries in coordination with local volunteers and distributed free healthcare equipment to destitute elderly. Following healthcare equipment were distributed among the needy persons;



Give India has also been mobilising financial resources for this campaign, particularly for providing wheel chairs, walkers, adult diapers and bed pan to destitute elderly living in slum areas.

During the year, Agewell Foundation has also started distribution of Food Packets (containing Rice, Atta, Pulses, Edible Oil, Sugar, Masale, etc.) to destitute older persons living in BPL (below poverty line) families.

Trained counsellors of Agewell Foundation provide following services as and when required by Agewell Family Members;

- A companion who will spend time with them, heal the loneliness as they grow even older
- Medical support in the form of consultations, medicines and people on whom they can depend in case of an emergency
- Someone who will look after their security concerns and protect their property
- Expert guidance in legal and financial matters
- General assistance such as paying their bills on time, being their escort & taking care of their chores



ACTIVITY –II Nationwide District-level Voluntary Action Network

In the process of setting up nationwide network of Voluntary Action Groups in the country to provide for the older persons, Aadhar had contacted Non-governmental Organisations/Voluntary Organisations and individuals including social activists, chartered accountants, district collectors, chief medical superintendents, superintendent of police, chairman of bar associations, head post masters etc. for identification of socially committed individuals & organisations.

As on 31st March 2015, over 7500 Primary Agewell Volunteers & over 80000 Secondary volunteers spread across 640 districts of the country were successfully working voluntarily for the welfare of older persons locally.

Agewell Foundation has embarked upon an ambitious social contact programme of reaching out to over half a million school children in Delhi in a bid to set off a feeling of acceptance and affection for the elders. Children without grandparents will be encouraged to meet up with and share a little

cheer with the elderly persons in their neighbourhood. The programme will involve the school authorities, teachers and parents as well via the children.
